Course Description

This course provides on introduction to the legal foundations of health com

in America, it is the responsipinity of the American government to promote

and protect the health and welfare of the public while respecting the interests, and upholding the rights, of the individual. The content of this course addresses how the law balances these collective and individual rights. The material covers a broad range of legal issues in health care, including autonomy, privacy, liberty, and proprietary interests, from the perspective of the provider(s) and the patient.

The course is divided roughly into two parts.

PSC 236/PH 236 Fall 2013

Part I: This first part of this course will explain (and provide the opportunity for students to practice) the skills necessary to read, understand, and analyze legal documents (legislation and legal opinions) affecting individual and public health in America. The content will include the structure of government, the foundations of health law, and an introduction to legal thinking.

Part II: The remainder of the course will provide the student continued opportunity to practice the skills developed in the first part of the course.

The content will focus on insucour and public health and prototic measurement individual rights (physical and biological interventions to control infectious disease), regulation of individual decision-making (including, but not limited to, abortion and end-of-life decisions), and the Patient Protection and Affordable Care Act.

Course Objectives:

Upon completion of this course students will have a general understanding of the role of governments and law in promoting and protecting health, including the functions of courts, legislatures, and administrative agencies in relation to health care law and policy; understand the relationship between the legal system, health care providers, and patients; be able to identify and analyze legal issues in health care; and be able to effectively communicate, both orally and in writing, the interpretive understanding of a case, statute, and complex regulatory scheme.

Specific learning objectives include the ability to:

- 1. Distinguish and discuss the role of the federal government and the various state governments in promoting and protecting the health of citizens:
- 2. Identify, distinguish, and discuss the relationship between community health issues and individual health issues;
- 3. Describe the evolution of the role of the physician and the nation in health care decisions;
- 4. Identify and analyze legal issues in health care; and
- 5. Communicate the interpretive understanding of a case or statute, when we complex regulatory scheme, both orally and in writing.

1. Class participation.

Reading and lectures are designed to complement each other rather than to

required. Informed class participation and attendance are worth 20% of the final grade. During six class sessions, each student will write and turn in answers to questions about the material. The questions may ask the students to link the reading to the lecture and/or discussion. You may refer to the readings to answer the questions, however, the time allotted will require that you have read the material in advance. These in-class assignments are worth 4 points each. Students may drop one assignment during the semester to allow for unanticipated absences. Students may earn the remaining four points through active participation in class discussions.

- 2. Biographical statement
 - The biographical statement is designed to provide me relevant information about your prior exposure to the course material and personal learning objectives for the semester.
- 3. Case brief questionnaires.

Reading legal opinions is a skill that requires practice. The case brief questionnaires will provide you with questions to facilitate a close reading and understanding of the different components of the opinion.

- 4. End of course reflection & self-assessment.
- 5. Final exam.

Additional educational activities and extra credit

Periodically, I will announce public lectures or other educational opportunities that would compliment the material in this course. Students are encouraged to attend these events. Students who attend announced lectures and write a one page summery of the event connecting the content to the course and reflecting on how the event may, or may not, have contributed to the student's educational experience will be awarded .5 extra credit points.
